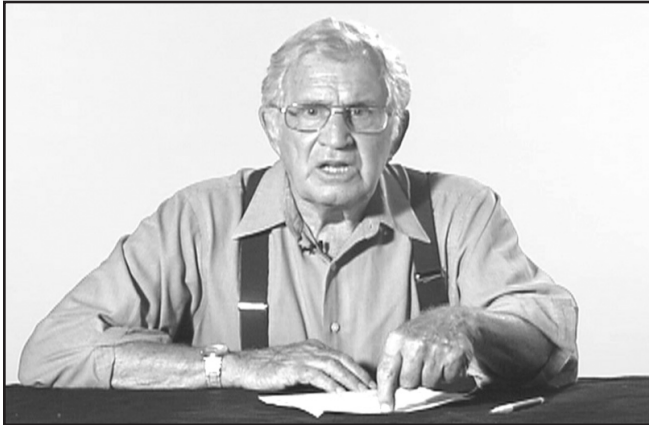

TO WITHDRAW YOUR SUPPORT FOR THE PETITION:

If you have signed the petition, you can get your name removed. Print and fill out the affidavit below. The affidavit will need to be notarized. Notaries can often be found at a local bank, large business or county offices. After you have filled out the form and had it notarized you should mail a copy of the affidavit to your local county clerk (addresses can be found at <http://www.sos.state.ne.us/elec/clerks.html>) and also mail a copy of your affidavit to the Secretary of State Elections Division, Nebraska State Capitol, PO Box 94608, Lincoln, NE 68509.

Be careful what you sign.

The Nebraskans for the Good Life Coalition offers the following guidance to the public when dealing with petition circulators:

- If someone approaches you with a petition, don't feel intimidated or pressured to sign.
- If you are harassed by a petition circulator, you can notify the authorities.
- If you encounter petition circulators on private property, ask the manager or business owner to remove them from the premises.
- By state law, circulators must read you the object of the petition. You have the right to read the entire language in the petition before you sign.
- If you have already signed the SOS petition and realize you have made a mistake, you can have your name removed by signing an affidavit, having it notarized and sending the form to the Nebraska Secretary of State, Election Commissioner or County Clerk on or before **July 7**. You can also take the same steps if a circulator violated the law by not reading you the object of the petition.
